## International Organization/ Official Visa

This type of visa is for applicants from International Organisations recognized by the UN. Official visas are issued for a stay in Myanmar up to 70 days and are valid for entry into the country within three months from the date of issue. The stay will be start count on the arrival date to Myanmar.

### REQUIREMENTS TO BE SENT TO EMBASSY (per applicant)

1. Original Passport with at least six months validity and six blank pages
2. Completed application form of Entry visa (Please apply in English) ([Download PDF](#))
3. TWO recent passport size colour biometric photos with white background (Please glue and no clips, no staples) (Please see requirements in General Guidelines Session)
4. Visa fee of 50.00 Euro (Please see payment method in General Guidelines Session)
5. The request letter from the Organization in Austria and the invitation letter from the Organization that have registered according to Myanmar Association Registration Law (Type of visit, tentative programme, applicant's name, passport details, position, travel dates and duration of stay must be included)
6. The copy of valid registration of Organization from Myanmar.
7. Recommendation by the focal Ministry / Organization in Myanmar
8. Place of Business within Myanmar, type of Business, undertaking to abide by the existing national Laws
9. Self-addressed return envelope with Austrian stamps for registered letter or courier satchel large enough to hold all passports for safe return. For international return mailings, enclose a postage fee of minimum 10 Euro in cash (cheque and bank transfer are not accepted. International coupons for postage fee are not accepted.)

### MULTIPLE JOURNEY ENTRY OFFICIAL VISAS

Multiple journey entry business (MJEV) visas are for those who has been granted at least two single entry official visas by Embassy in Vienna. The person who has been granted single entry official visa can apply initially MJEV 3 months and then MJEV 6 months to MJEV one year.

### REQUIREMENTS TO BE SENT TO EMBASSY (per applicant)

1. Original Passport with at least six months validity and six blank pages
2. Completed application form of official visa (Please apply in English) ([Download PDF](#))
3. TWO recent passport size colour biometric photos with white background (Please glue and no clips, no staples) (Please see requirements in General Guidelines Session)
4. Letter of request from applicant's company for requesting Multiple Journey Entry Visa. (Please state why it is necessary for this type of visa.)
5. Letter of Invitation from Myanmar company / organization and a copy of company registration (certificate of incorporation)
6. Visa Fee 190.00 Euro (for MJEV 3 months), 380.00 Euro (for MJEV 6 months) and 570.00 Euro (for MJEV one year)
7. Copy of the previous visas that have been granted by the Embassy
8. There is no express service available
